Second, in a betslip containing multiple bets, if the first bet you add a wager amount to is a parlay bet, the next non-parlay bet (ex. any straight bet like a moneyline, total, spread, etc.) you add a wager amount will be marked as the Eligible Bet. Parlay bets will only be marked as the Eligible Wager when they fulfill the criteria of being *the only* single wager on your betslip.
