Official Rules

Promotional Period

1. Hollywood Gaming at Dayton Raceway will conduct a “Choose the Champs” promotion beginning Tuesday, September 3, 2024 through Sunday, January 5, 2025: contingent on the start and duration of the 2024 National Football League (NFL) season.
2. All times referred to throughout these rules are Eastern Time (ET).

Eligibility

1. Participation is open to all loyalty club members. Membership is free. Patrons may enroll at Player Services.
2. Must be 21 years of age or older to obtain a player’s card and participate in this promotion.
3. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.
4. A government issued photo ID is required to verify age and identity.

Weekly Implementation:

1. Selection windows each week will begin on Tuesday at 1:00pm until the following Saturday at 11:59pm.
2. Loyalty club members are eligible for one complimentary selection per week.
3. Loyalty club members that earn fifty (50) tier points through play on the Sunday prior to the current week selection window will earn an additional selection for that week.
4. Earn one (1) tier point for every \$5 of coin-in.
5. In the event of a kiosk malfunction, the promotion will suspend and will resume when malfunction is resolved.

7. Participants are responsible for checking and confirming their selections prior to leaving the kiosk.
8. Selections may not be changed once participants leave the kiosk.
9. Participants can choose to receive a receipt of their picks for each week they register.

 - In the event that there is a tie between both teams at the conclusion of any game, points will not be awarded for that game.
 - If no participant picks the correct total combined score for the tiebreaker game, the participant(s) whose total combined score which is closest to and below the total actual combined points scored will win. If there are any ties, the participant who made their selection first will place higher.
12. Weekly winners will be posted at Player Services by 1pm on the Tuesday following that week's games.
13. All weekly free play prizes will be available for redemption at any promotional kiosk beginning at 1pm the following Tuesday. Any prizes that are not redeemed by midnight the following Monday will be forfeited.
