Promotion Period

1. Hollywood Gaming at Dayton Raceway will conduct a “Nifty Fifty” promotion every Tuesday in November 2024.
2. Entries are only valid for the day in which they are printed.
3. All times referred to throughout these rules are Eastern Time (ET).

Promotion Eligibility

1. Participation is open to all loyalty members age 50+.
2. Must be 21 years of age or older to obtain a loyalty card and participate in this promotion.
3. Membership is Free. Patrons may enroll at Player Services.
4. A government issued photo ID is required to verify age and identity.
5. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.

Prizes & Drawing

1. Eligible loyalty members must activate promotion by swiping their loyalty card at any kiosk located near the promotion area and selecting the “Nifty Fifty” promotion from 7:00am to 4:59pm on promotion day.
2. It is the patron’s responsibility to activate their bonus during the promotion period.
3. Un-activated bonuses will expire at the conclusion of the promotion period.
4. Bonuses are predetermined and range from \$5 - \$25 PENN Bonus Play.
5. Only one bonus offer is available per person per promotion day.
6. Bonuses must be claimed at a kiosk each week between 7:00am to 5:00pm and will progress in the order in which they are redeemed each month.
 - First Visit - \$5 PENN Bonus Play
 - Second Visit - \$10 PENN Bonus Play
 - Third Visit - \$15 PENN Bonus Play
 - Fourth Visit - \$20 PENN Bonus Play
 - Fifth Visit (when applicable) - \$25 PENN Bonus Play
7. Bonuses reset to the First Visit at the beginning of each month.
8. PENN Bonus Play will expire in one (1) day.
9. Winners are responsible for all applicable federal, state, and local taxes, as well as title, delivery, and licensing fees.
10. PENN Bonus Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
11. PENN Bonus Play is valid only at Hollywood Gaming at Dayton Raceway.
12. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the
